

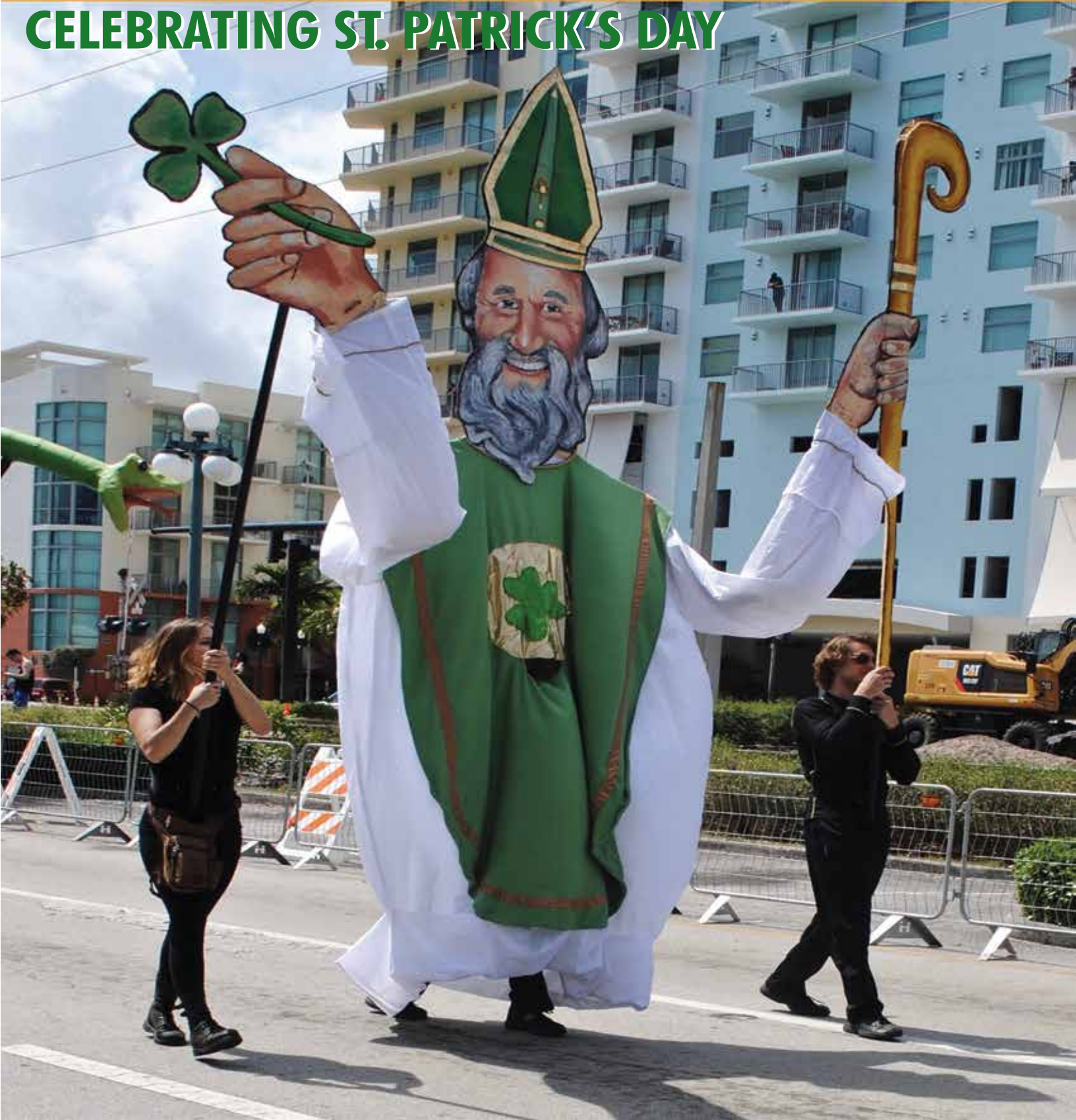

The event will take place on Wednesday, April 23, 2025, at the Festival of Arts and promises an unforgettable night of celebration, entertainment, and artistic excellence.

Additionally, LBAA will present a Lifetime Achievement Award to art historian Jean Stern for his extraordinary impact on California Impressionism and Laguna Beach's cultural legacy.

Guests will be welcomed to a KXFM 104.5 Red Carpet, where nominees and attendees will be interviewed before the festivities begin. Throughout

the evening, attendees will enjoy performances by the Laguna Community JaZz Band, live caricatures by David Fleischmann, mesmerizing airbrush body art by Star Shields, and a variety of art demonstrations by Laguna College of Art & Design (LCAD) students. The evening's host will be the always witty and entertaining Chris Quilter, a longtime arts supporter known for his work with No Square Theatre and his contributions to the local community, including his instrumental role in the creation of the Susi Q Senior Center, named in honor of his mother.

"I was honored to be asked to emcee the show, and I was humbled by the thought of how many people must have declined the opportunity," said Chris Quilter, a longtime writer for No Square Theatre's "Lagunatics." "In all seriousness, Laguna Beach is a small town with a big artistic heart, and it's a privilege to celebrate the people who make this community such a special place for the arts."

Irish Sweet Soda Bread

Recipe courtesy of "Cookin' Savvy"
Servings: 4-6

- 4 tablespoons butter, melted
- 1 cup sugar
- 1 1/2 cups buttermilk
- 4 cups self-rising flour
- 1 cup currants
- 2 tablespoons sanding sugar (optional)
- coffee or tea, for serving (optional)

Heat oven to 375 F. Mix melted butter and sugar then add buttermilk. Mix in flour and currants. Flour hands and counter. Add sanding sugar to dough, if desired, and knead into ball. Grease small Dutch oven or pie plate and bake 40 minutes. Serve with coffee or tea, if desired, or as a dessert. Substitutions: Raisins can be used in place of currants.

Irish Beef and Beer Pot Pie

Recipe courtesy of "Cookin' Savvy"
Servings: 4-6

- 1 pound ground beef
- 1 cup stout beer
- 3 tablespoons flour
- 1 can (15 ounces) tomato puree
- 1 tablespoon Worcestershire sauce
- 1 tablespoon garlic powder
- 1 cup beef broth
- 1 bag (28 ounces) hashbrowns with peppers and onions
- 1 can (14 ounces) carrots, drained
- 1 can (14 ounces) peas, drained
- salt, to taste
- pepper, to taste
- 1 sheet puff pastry, thawed
- 1 egg

Heat oven to 400 F. In large skillet or Dutch oven, brown ground beef; drain and set aside. Over medium heat, deglaze skillet with beer and whisk in flour. After thickening, whisk in tomato puree and add Worcestershire sauce. Mix in ground beef, garlic powder and beef broth. Add hashbrowns, carrots and peas. Season with salt and pepper, to taste. Simmer 20-25 minutes, stirring occasionally. Place puff pastry sheet on cookie sheet. Beat egg and brush over pastry. Bake 10 minutes. Place hot puff pastry on top of beef mixture and serve.

ST. PATRICK'S DAY IN AMERICA AND IRELAND

Before doing my recent research on St. Patrick's Parades, I assumed, as I imagine that many people do, that the mother of all St. Patrick's Day parades must be in Ireland. In studying the history of the celebrations I learned that my assumption was incorrect.

In fact, the "original" St. Patrick's Day Parade was held in New York, 16 years before the Declaration of Independence was signed. The tradition of celebrating St. Patrick's Day parades began as a response to oppression. An English law forbid the Catholic's parades, but allowed a religious procession after Mass. So, on this technicality, the Irish Catholics got a permit for a church procession. The St. Patrick's procession would leave from the Cathedral after Mass. Therefore the original parades were actually an act of defiance.

While the parades have become an accepted part of the mainstream in the United States, historically, that has not been the case. There are several cities that started having parades in the early years, only to suspend them during times of hardship. The times of hardship included anti Irish sentiment, two World Wars and the Great Depression.

Up until the mid nineteenth century, the majority of Irish immigrants in America were members of the Protestant middle class. The 1845, the Great Potato Famine hit Ireland and close to a million poor, uneducated Catholic Irish started pouring into the United States. The Irish immigrants were despised when they first immigrated, and had trouble finding even menial jobs. They soon began to realize that their great numbers gave them political power and they began to organize. Their voting block became known as the "green machine". The St. Patrick's Day parades became a show of strength for Irish Americans and a "must attend" event for politicians.

As the parades became part of the mainstream society, Protestants celebrated alongside the Catholics and they all enjoyed the party. What started as a religious procession became a celebration with music, dancing and green beer. St. Patrick's Day and green beer have become synonymous. It's traditional



in many cities for everyone to go on a pub crawl after the parade and drink copious quantities of green beer, which is simply regular beer with some green food dye added.

While the St. Patrick's Day party reigned in American, the Irish observed St. Patrick's Day as a holy day. St. Patrick's Day had been a solemn holy day for centuries. As a holy day, the saloons were closed, which was the opposite of the parties that occurred in America.

St. Patrick lived over 1600 years ago. He had endured a turbulent life. He was captured and enslaved at the age of 16. He worked as a slave in Ireland, part of that time working as a shepherd. He escaped and became a man of God, entering the priesthood. He was educated in a monastery in France. He was made a Bishop and was returned to Ireland, this time to work as a missionary and convert the pagans to Christianity. He was successful in converting many people to Christianity.

The legend of St. Patrick is that he led the snakes out of Ireland. However, as snakes are not indigenous to Ireland, it


is believed that the legend is symbolic. Most believe that the snakes of legend were actually symbolic of the pagans that were converted. St. Patrick is credited with using a shamrock to explain the holy trinity to pagans. Thus the shamrock is symbolic of the holy day.

In 1995, Ireland set up a St. Patrick's Day Festival, with the goal of capitalizing on the popularity of the celebration and to encourage tourism to Ireland.

The First St. Patrick Festival was held on March 7, 1996. In 1997 the event was a 3 day festival. This year the five day festival will feature 4,000 performers, with one millions people celebrating. Events include music, street theater, family carnivals, comedy, street performances, dance, a treasure hunt, night spectacles, and many celebrants.

In Ireland the St. Patrick's Day Festival is an event that draws locals and tourists. The country, with it's long history of honoring St. Patrick and his good works sounds like a great party. On the other hand, if you want to go to the original St. Patrick's Day Parade, New York is the place. **Photo by Johnny Cohen**

BAKED BREAD TO CELEBRATE ST. PATRICK'S DAY

From hearty stews to minty pies, St. Patrick's Day celebrations are all about enjoying the flavors of the holiday. Whether you're cooking up a full meal or simply serving appetizers, this Irish Potato Bread makes for a simple, tasty snack to feed your crowd.

Irish Potato Bread

- 2 medium or large russet potatoes
- 1 egg
- 1 egg white
- 1/3 cup canola oil
- 3/4 cup milk
- 2 tablespoons green onion, minced
- 1/2 teaspoon caraway seeds
- 3 1/4 cups all-purpose flour, plus additional for dusting and kneading
- 1 1/2 tablespoons baking powder
- 1 teaspoon salt

Heat oven to 375 F.

Peel potatoes. Slice one potato and boil in saucepan 15 minutes, or until tender. Remove potato from saucepan into large bowl. Mash potato then set aside.

Grate second potato onto cloth. Wring potato in cloth to remove excess water. Add grated potato to mashed potato in large bowl. Add egg, egg white, oil, milk, onion, caraway seeds, 3 1/4 cups flour, baking powder and salt. Stir with wooden spoon until mixture is soft and sticky.

Turn dough onto floured surface. Adding flour as needed, knead dough to form 8-inch round shape with slight dome. Place dough onto baking sheet lined with parchment paper. Cut large "X" on top of dough about 1/2 inch deep.

Bake 55 minutes until golden brown. Cool on wire rack 1 hour before serving. (Culinary.net)

6 STEPS TO SPRING INTO LAWN AND GARDEN CARE

If cooler weather has you longing for sunny days outdoors, take heart. Once spring rolls around, you can prepare your yard for months of warm-weather enjoyment with these tips.

Clear the Yard

Remove any leaves, rocks or sticks that may have accumulated then cut the grass as short as you can.

Dethatch

Use a thatching rake to remove dead roots and grass.

Treat Weeds

Apply herbicide to treat weed-infested areas. Allow the weed killer to work for about a week then rake to remove dead weeds.

Add Seed and Fertilizer

Depending on your lawn's needs, overseed or spot seed to fill in thin spots. Use a grass variety that matches your climate for best results. Select and apply fertilizer consistent with your grass type then water thoroughly.

Clear Garden Beds of Debris

Remove leaves and other matter that piled up in your garden during the cooler months. Gently turn the soil and work in fresh fertilizer.

Start Planting

Early spring is the time to divide perennials and plant hardier vegetables, such as onions and potatoes. You can



also start indoor seeds, if necessary, and move plants outdoors when the weather permits.

Getting some of your lawn and garden care underway now can make those warmer, sunny days feel closer in

"Over the years, we've seen our customers come up with all sorts of inventive solutions like eero devices inside weatherproof boxes, in outdoor closets and even strapping them to poles with rubber bands."

Clever, sure, but ultimately not a permanent fix.

It led Weaver and his team to create eero Outdoor 7, which is designed to take eero Wi-Fi to the great outdoors. It's the same sort of device as the one designed for indoor use, but it was a whole different animal to construct because it needed to withstand Arizona summers, Minnesota winters, and everything else Mother Nature dishes out. The product is available now just in time for the holidays, and it's something the whole family will enjoy now through the summer and beyond.

Here are some really fun ideas that outdoor Wi-Fi can help out with:

Keep all outdoor security cameras connected. Security is a growing concern for many homeowners, but a camera is only as good as its Wi-Fi connection. With this new technology, you can have multiple cameras throughout your property, from the garage to the backyard.



Extend Wi-Fi to a tiny house on your property. Whether you use the dwelling as a guest house, a rental, a dedicated home office or a she-shed, the Outdoor 7 makes it easy to stay connected.

LA JOLLA VILLAGE'S QUEENSTOWN VILLAGE: A SLICE OF NEW ZEALAND

With a Kiwi-inspired lineage and the spirit, love, and good nature NZ Eats Group welcomes guests to experience a taste of New Zealand at any of their restaurants. Queenstown, the adventure capital of New Zealand, is known for breathtaking landscapes, outdoor thrills, and a vibrant town center. That spirit of adventure and hospitality is what NZ Eats hopes to bring to their dining establishments, inviting guests to enjoy good food, laughter, and lasting memories. Their San Diego restaurant portfolio includes Queenstown Public House (Little Italy), their flagship location, Ragland Public House (Ocean Beach), Queenstown Bistro (Westfield UTC mall), Dunedin New Zealand Eats (North Park), Bare Back Grill (Pacific Beach), and Queenstown Village (La Jolla Village).

My wife, Mary, and I had the pleasure of dining at their La Jolla Village location.

This beautiful space features an inviting patio perfect for people-watching, while the interior showcases stunning art deco décor. General Manager Ty Anson shared that the decor shifts every three months, and since it was the day before Valentine's Day, the restaurant was beautifully decorated. Guests were greeted with a six-foot tiered display of roses, greenery, candles, and wine at the entrance, and Valentine's Day-themed decorations throughout, setting a cozy, romantic ambiance.

At the suggestion of our server Chanel Enriquez, we started with the

Baked Brie Shareable Plate, a rich and creamy brie round, oozing with luscious oils. The platter was accompanied by tart green apple slices, honey, almonds, and baked crostini. We also ordered the Flower Pot Bread, a signature house-baked bread baked in an actual flower pot, paired with silky honey butter. The Brie and Flower Pot Bread was sympatico.

For entrées, I was drawn to the Parlor Pot Pie, another one of Chanel's recommendations. As a pot pie lover, this was an easy choice. The rimmed dish was filled with tender chicken, carrots, peas, celery, and onions in a creamy gravy, topped with golden puff pastry and served with a house-made cheddar biscuit. The rich, buttery crust and creamy filling was ultimate comfort food.

Mary, on the other hand, adores meatloaf, so she took Chanel's suggestion and ordered the Wellington Meatloaf, a delicious blend of organic beef and pork mixed with carrot, onion, celery, and cheese, topped with crispy fried onions. It was served with sweet potato mash, sautéed carrots, and a tangy, spiced tomato chutney. The flavors were perfectly balanced, and the texture of the meatloaf was just right. As Ty checked in on us, he shared that the New Zealand Meat Pie, Parlor Pot Pie, Wellington Meatloaf, and Pan-Seared King Salmon (sourced from New Zealand) are their most popular dishes.

The wine list featured a nice selection of sparkling, rosé, white, and red wines by the glass as well as a large collection of bottles. With New

Zealand's reputation for world-class Sauvignon Blanc, I wasn't surprised to see three different by the glass selections available. Mary paired her meal with a Laird Chardonnay, while I debated between Caymus and Far Niente Cabernet Sauvignon. Since I had Caymus the night before, I opted for the Far Niente Post and Beam Alexander Valley Cabernet Sauvignon, which paired beautifully with the Wellington Meatloaf. In addition to wine, guests can also enjoy creative cocktails, and a variety of draft and bottled beers, including an IPA and Blonde Ale from New Zealand.

Executive Chef Yohalmo Rosales' menu offers a variety of choices, including lighter fare such as dinner salads and sandwiches, as well as rich, comforting New Zealand Faves and Dinner Plate selections. Queenstown also offers Weekday Brunch (Monday-

Friday, 11 am to 3 pm) and an expanded Weekend Brunch (Saturday-Sunday, 9 am to 3 pm), with dinner service starting after 3 pm daily. The La Jolla location also features a café and eatery where guests can enjoy indulgent treats like the gluten-free Nectarine Grove Cinnamon Bun.
