## BOWERS MUSEUM ACQUIRES STUNNING NDWANGO BY UBUHLE WOMEN

The Bowers Museum is thrilled to announce the acquisition of a remarkable new ndwango (beaded artwork) by South African artist Zondile Zondo. The piece, titled *Dressed for the Dance*, is a vibrant celebration of cultural heritage and female empowerment, highlighting the artistic excellence of the Ubuhle Women, a community of Xhosa and Zulu women artists living and working together in KwaZulu-Natal, South Africa.

About the Artwork:

- Artist: Zondile Zondo
- Title: *Dressed for the Dance*
- Year: 2023
- Location: KwaZulu-Natal Province, South Africa
- Medium: Glass beads sewn onto fabric

• Acquisition: Bowers Museum Purchase made possible by generous contributions from the Bead Society of Orange County, Bowers Museum Collectors Council, Janis Agopian, and the Marion & John Scott Trust Cattle hold deep cultural significance for the peoples of eastern South Africa and frequently feature in the ndwangos created by the Ubuhle Women. *Dressed for the Dance* draws inspiration from the matric dance, a celebratory event preceding the graduation of South African girls from high school. Despite its large horns suggesting it might be a bull, the depicted

Ankole is female. According to Zondile Zondo, the artwork captures the joy and excitement of graduation and symbolizes the strength of a young girl poised to find her place in the world.

About Ubuhle Women:

The Bowers Museum previously showcased the extraordinary talent of the Ubuhle Women in the exhibition *Ubuhle Women: Beadwork and the Art of Independence*, which ran from July 1, 2023, to August 27, 2023. The exhibition featured a new form of bead art called ndwango, developed by a community of women in rural KwaZulu-Natal, South Africa. The six artists featured in the exhibition create their beadwork on black fabric reminiscent of the Xhosa headscarves and skirts from their childhoods. By stretching the textile like a canvas, the artists transform the flat cloth into contemporary artworks adorned with Czech glass beads.

The ndwangos, meaning "cloth" or "rag" in Xhosa, are created using skills passed down through generations. Each piece is crafted in a unique style that the artists describe as coming "directly from the soul." The artworks feature both abstract and figurative subjects, with a single panel taking more than 10 months to complete. Ubuhle, meaning "beauty" in the Xhosa and Zulu languages, refers to the shimmering quality of light on glass

beads, which holds particular spiritual significance for the Xhosa people. The meticulous skill and scale of ambition involved in creating each panel become evident as each tiny bead catches the light.

Exhibition and Viewing:  
*Dressed for the Dance* is now a permanent part of the Bowers Museum's collection. This stunning piece is on view just outside the Norma Kershaw Auditorium in the Dorothy and

Donald Kennedy Wing, allowing visitors to appreciate its cultural significance and

artistic mastery on an ongoing basis.

About Bowers Museum:

Located in the historic heart of Orange County, Bowers Museum's 9 permanent collection exhibitions showcase art and artifacts from cultures around the world. As the largest and one of the oldest museums in Orange County, Bowers has been voted 'Best Museum' in Orange County for the past 30 years (as of 2023). # WHAT YOU (AND YOUR CHILD) SHOULD KNOW FOR KINDERGARTEN AND BEYOND

Starting kindergarten is a major milestone, one that sets the stage for future learning. Ensuring children are well-equipped to enter kindergarten sets them up for a successful school year in the short term and academic career in the long term.

Kindergarten readiness encompasses a wide range of skills, including academic, social and physical abilities. Yet while many parents think of kindergarten as the formal start of their children's learning, 90% of children's brain development occurs during the first five years of life.

The brain is incredibly receptive during these formative years, making it a critical time for children to receive exposure and guidance in diverse areas. Enrolling them in a quality preschool or pre-K program is one way you can ensure they're creating building blocks for the future, but there are also steps you can take at home.

Try implementing these simple habits, recommended by Primrose Schools Chief Early Learning Officer Dr. Amy Jackson, into your family's day-to-day routine:

Read to your children daily to build early literacy skills. This is a good habit to begin as early as infancy because it promotes language development, literacy and understanding of others. Make library trips and story times a special treat for toddlers and encourage preschoolers to read to you by describing what is happening in the pictures or making up their own stories. Keep books in the car so you have a fun way to pass the time on long trips or while waiting for appointments.

Schedule playdates for social development. Once babies are able to sit independently, they'll likely enjoy playdates. At this age, playdates should be closely monitored since babies explore with their hands and mouths. At ages 1 and 2, young children tend to engage in parallel play rather than interacting, but organizing small groups of toddlers can continue to promote



social development. Older toddlers enjoy more interactive play and begin to learn concepts like sharing.

Practice counting objects to 10 or more together. It's easy to make "math talk" part of your everyday experience in other ways, too. When reading a story, ask children to count the objects on each page. When eating, encourage math connections by having children count the items on their plates. Children can also explore math through common toys and games, like shape sorters, knob puzzles and nesting cups for infants and toddlers; and large puzzles, sand or water tables and card games for preschoolers.


Encourage physical activities like playing on the playground. Play isn't just for entertainment; it's a building block for healthy growth. It helps children learn from the world around them and develop traits like generosity and honesty. Because it helps children release their full range of emotions and has therapeutic benefits, play also has positive effects on mental health. In addition to supporting their social-emotional well-being, children learn to navigate the world and practice motor skills while at play.

Establish routines at home. A structured school day is filled with routines that provide familiarity and comfort. Routines can serve similar benefits at home by helping children clearly understand what is expected of them and when. A morning routine makes it easy to check the boxes as you prepare for the day and work to get out the door on time. An evening routine helps everyone settle down and prepare for a good night's sleep.

Encourage self-regulation and social skills. Self-regulation is the ability to understand and manage your own behavior and reactions, often displayed during actions like taking turns, transitioning from one activity to another or cleaning up for dinner. Social skills include interaction and communication abilities like speech, body language and facial expressions, as well as the ability to play with others and make friends. As a parent, you can model these skills and play games that involve taking turns and cooperation. Playdates also help facilitate positive social experiences for children.



# Taste of Wine & Food

## CALIFORNIA WINE FESTIVAL RETURNED TO CARLSBAD'S PARK HYATT AVIARA RESORT

California Wine Festival, returned to Carlsbad's Park Hyatt Aviara Resort for two days of alfresco tasting events. Guests were able to try pours from esteemed winemaking regions across California, paired with gourmet appetizers from many North San Diego County's top restaurants. Day 1 kicked off with a Sunset Rare & Reserve Tasting, a special experience for wine enthusiasts that featured a sparkling wine reception that flowed into sampling hard-to-find reserve wines. Day 2, the wine tasting experience continued at Park Hyatt Aviara Resort's Heron Lawn. Attendees continued their wine education and exploration through intimate conversations and tastings with winery representatives hailing from California's world-famous wineries as well as culinary talent from the region's most lauded restaurants. Emily Kaufmann, Executive Director, California Wine Festival shared, "We founded this event in hopes that wine enthusiasts can engage with representatives from wineries that they already know and love, while also discovering new wines that they've never heard of."

Last year, we discovered Gus's World-Famous Fried Chicken and planned to make this our first stop at this year's show. Gus's is the best chicken I have ever had. The large pieces with a thin, hot and spicy batter fried in peanut oil is mouthwatering delicious. I dream of a Gus's opening in the San Diego area. Mynor Espinoza, Gus's Director of Marketing and Public Relations was not hopeful for a San Diego area opening in the near future, but said they have

discussed the possibility of a San Diego location. On our way over to Gus's we saw Orfila Vineyard and Winery, Executive Chef, Luke Morganstern. Luke shared some of the changes at Orfila. They closed their Oceanside Tasting Room to join forces at Lake San Marcos's Brinkman's restaurant. Additionally, Orfila will be putting in a full kitchen at their main Escondido location. Amalfi Cucina which opened several sites in San Diego's North County, purchased Orfila's Oceanside location. We learned about the Orfila updates while enjoying their 2023 Sauvignon Blanc, 2023 Sangiovese Rose, and the 2020 Sangiovese.

It was a pleasure reconnecting with Hall Napa Valley's Lisa Covey, Director of Public Relations, especially after my visit to the winery earlier this summer when I met with Megan Gunderson, VP of Winemaking. Covey presented a standout lineup: the 2023 Napa Valley Sauvignon Blanc, 2018 Terra Secca Red Blend, and the star of their lineup, the 2019 Eighteen Seventy-Three. Named after the historic Bergfeld Vineyard in St. Helena, this wine dazzled with a floral nose, blueberry hints, and a palate of ripe dark fruit and smooth tannins—a true testament to Hall's winemaking prowess.

Next, we ventured to the Booker Wines booth, where Brand Ambassador Carson O'Connor poured some Paso Robles' winners. The Harvey & Harriet wines, dedicated to owner Eric Jensen's parents, are accessible, quality wines that won't break the bank. The 2021 Chardonnay and 2020 Red Blend exemplified this philosophy, offering

excellent value. For those seeking a more indulgent experience, the 2019 Fracture Syrah, aged 18 months in new French oak, impressed with its dark, opaque color and complex palate of black cherry, blackberry, clove, and coffee—a perfect match for hearty beef or pork dishes.

The journey continued at Hope Family Wines, where Brand Ambassador CJ Gormley and wine educator Maddi Teague showcased a crisp 2022 Chardonnay, a 2023 Cellar Select Rosé, and a 2022 Malbec with a hint of black tea. Their flagship 2021 Austin Hope Cabernet Sauvignon did not disappoint, rounding out a strong showing from this Paso Robles favorite.

In between tastings, a visit to Scott Condon's Inferno Wood Fired Pizza was a must. Their light, airy crust—thanks to a 48-hour fermentation—was the perfect base for Bianco DiNapoli tomatoes and locally sourced ingredients. If you're in need of catering for a special event, Inferno delivers with style.

At the Adobe Road booth, Callum Clarke, Western Regional Sales Director, impressed with a robust lineup that included a Chardonnay and Pinot Noir sourced from Petaluma Gap, specifically

Sangiaco Vineyard's Roberts Road vineyard. However, the highlight was the 2018 Cabernet Sauvignon from Napa Valley's Beckstoffer Georges III vineyard. With a nose of plum and cigar notes, and a palate bursting with dark fruit, spice, and firm tannins, this wine earned 94-point ratings from both Wine Spectator and Robert Parker. It was my top pick of the event.

Finally, we visited Lloyd Cellars, where husband and wife team Rob and Bonnie Lloyd offered a taste of their expertise. Having experience as Rombauer's Assistant Winemaker, Associate Winemaker, and Winemaker spanning 2001 to 2008, I correctly guessed that the Lloyd and value priced Prescription Chardonnays were going to be good. The 2022 Lloyd Pinot Noir delivered classic cherry and cola flavors with a lingering finish, while the 2021

Prescription Cabernet Sauvignon, with its blackberry notes and soft tannins, proved to be a well-priced, solid everyday wine reminding me of the Harvey & Harriet brand.

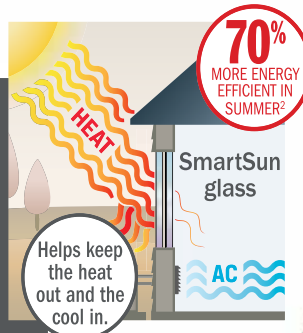
